Waiver, indemnity and release

In consideration of Dan and Gloria Timmons, and Allegiance Ranch and Equine Rescue, located at 3448 County Road 4, Erie, CO 80516, (the "Premises"), granting the undersigned the right to volunteer, sponsor a horse, and/or participate in horse riding and handling activities ("equine activities") on the Premises, I, for myself, my heirs, successors and assigns, and if I am a guardian of a minor, for such minor, his heirs, successors and assigns, hereby waive, release and discharge Allegiance Ranch and Equine Rescue, the property owners Dan and Gloria Timmons dated May 1, 2017, managers, agents, officers and employees (hereafter, collectively, "Allegiance Ranch") of and from all claims, demands, damages, actions and causes of action of any sort, for injuries sustained to my person, the horses and/or my property, for whatever reason, including, without limitation, negligence by Allegiance Ranch.

I assume all risks of injury to my person and property that may be sustained in connection with any equine activity conducted in and about the Premises or at any other locations as may be utilized by Allegiance Ranch.

I hereby further agree to indemnity and save harmless Allegiance Ranch against liability, damages, loss of expense arising from any bodily injury, including death, at any time sustained by me or my relatives, heirs, subcontractors, guests, permittees, agents, servants of employees or on account of damage to property arising out of, or in consequence of, the Premises, animal handling, and equine activities.

I understand by signing this waiver I also give permission to have photos taken of me (and my child/children) used in social media, marketing, and/or outreach materials for the purpose of promoting Allegiance Ranch and Equine Rescue.

I am 18 years of age or older, I certify that my attendance and participation in the stated equine activities is voluntary, and I have read and understand the foregoing Waiver, Indemnity and Release. I have inspected the Premises and I understand that equine activities are inherently dangerous and I assume the risk of all dangerous condition concerning the Premises and the equine activities, and I waive all specific notice of the existence of such conditions.
